
We value our relationship with you and want to make sure that you are aware of our procedures regarding exporting.

The EU Export Council is in the process of drafting new regulations removing the export sanction for European exports into Iran. If these measures do come to fruition (scheduled for June release), this does not affect the United States continued sanctions on Iran, which are not scheduled to be changed at this time.

Since RAPCO products are produced in the United States, ALL RAPCO products must still comply with the United States Export Administration regulations, which forbid exports to Iran.

We will continue to have our statement of compliance on Packing and Invoice documents as highlighted to the right.
